5. In the event of a tie in the highest score among participants, the Jury will deliberate to determine the best winner.

### Jury Rules and Regulations

1. Jury members are required to arrive **15 minutes before** the conference begins.
2. During the conference, jury members are not allowed to leave the venue without prior permission from the committee.
3. Each jury member must carry out their duties following applicable norms and assessment criteria, fairly and impartially.
4. Jury members must maintain the confidentiality of participant assessments until the winners are officially announced.
5. Jury decisions are final and cannot be contested.
6. Matters not yet regulated in these rules will be determined later (if necessary) based on deliberation and consensus.
